Rental conditions for a pitch

- 1) The week prices includes : a pitch for a tent, a caravan or a camping-car, a car park (6 persons max per pitch), access to showers (hot water), toilets and wash tub facilities. Access to the recreation ground, access to the heated swimming pool, open mid June till mid September. Bathing trunks are forbidden. Swimming costumes are obligatory. Bar open July and August.
- 2) All bookings must be confirmed by a first down payment of 50 € per week + 15 € for booking costs ( non refundable)
- 3) The balance is due the day before departure

Rental conditions for a mobile home

- 1) The week price includes the rental of : a mobile home, cottage or caravan, for registered persons, from Saturday 3.00 pm till Saturday 10.00 am (except week-end tariffs), a place for the car, the electrical connection, gas and water. Whenever you are not enrolled to these activities at the time of booking, you will then have to pay 4 € per day + tourist tax. Access to the recreation ground, access to the heated swimming pool, open mid June till mid September. Bathing trunks are forbidden. Swimming costumes are obligatory. Bar open July and August.  
It's forbidden for the lessee to re-rent his rental to other people
- 2) Rental is only confirmed with a first 25 % down payment + 15 € for booking costs ( non refundable). The lessor keeps an option for 5 days, which gives time to the lessee to send the first down payment.
- 3) The balance payment is due on arrival. No refunds will be made in case of late arrival or anticipated departure.
- 4) A complete inventory is done by the lessee on arrival. The lessee must advise the lessor for any missing or broken elements. The lessor will do the inventory before departure. A 250 € security deposit is asked on arrival, payable by credit card and reimbursed at the end of your visit after inventory with deduction made, in case of damaged or lost material. Cleaning must be done before leaving. If not, 53 € will be taken on the deposit.
- 5) In certain accommodations, pets are admitted (25 € extra per week)

General conditions

- 1) In case of inaccurate declaration of the lessee, this contract will be cancelled and the first payment will be kept by the lessor.
- 2) The booking will be real after written agreement of lessor
- 3) In case of cancellation : less than 30 days before de booking, the first down payment will be kept by the lessor, more than 30 days, the first down payment is given back to the lessee. In all case, the 15 € booking costs will not be given back.
- 4) The lessee must advise in case of lateness (in order to keep his booking). After 48 hours, if the lessee still did not advise, the lessor can book the accommodation or site to someone else (and first down payment will be kept).
- 5) The lessee declares having his own civil responsibility insurance.
- 6) In case of non respect of the campsite internal regulations, the lessor has the right to evict the lessee.
- 7) Pets are admitted but must be kept on a leash, tattooed and vaccinated against rabies. The vaccination documents must be presented at the campsite office. They are not accepted in the swimming pool, lavatories and games areas.
- 8) One car place only per accommodation
- 9) Visitors invited by the lessee must present themselves at the campsite entrance to register and pay a tourist tax.

De caution Barbecues with charcoal are forbidden. Bathing trucks are forbidden. Swimming costumes are obligatory.
